Clinic Package

This policy provides insurance coverage for members who are operating a clinic/business and have valuable contents or property to insure. The package includes Commercial General Liability (CGL), Contents, Crime, and Business Interruption to ensure comprehensive coverage for your business.

Commercial General Liability (CGL) Insurance protects you against claims arising from injury or property damage that you (or your business, including your staff) may cause to another person as a result of your operations and/or premises. For example, a patient may slip and fall on a wet floor in your office, or you may accidentally cause property damage to a patient's home during a consultation.

Contents include items usual to an office, including professional equipment, desks, chairs, filing cabinets and computers, as well as any stock, and improvements and betterments.

Crime coverage protects against financial loss due to dishonesty, fraud, or theft of money, securities or other property owned by the clinic/business.

Business Interruption insures against loss of income resulting from direct physical loss or direct physical damage to the premises by an insured peril (e.g. fire).
